### STEP 2 | Eligibility

Beginning in tax year 2024 (payable in 2025), legislation expands the Standard Homestead Exemption for Veterans with Disabilities (SHEVD) exemption to a qualified residence that is used by a veteran who was a member of the United States Armed Forces during World War II regardless of their level of disability rating. If the veteran qualifies under the World War II provisions, they do not need to fill out an annual reapplication/renewal form.

The term "World War II" means the period beginning on December 7, 1941, and ending on December 31, 1946. If **any** of the veteran's service was performed during this time frame, then the veteran is a World War II veteran.

### STEP 3 | Photo ID and Proof of Occupancy Required

All applications must include Photo ID and an Occupancy Affidavit. The name and address on the ID must match what is entered on the application, and been issued in year 2024 or prior. If your current name is different from a former name on any provided verification document(s) or the deed, you must submit documentation sufficient to explain the name change: a certified marriage certificate, divorce decree, etc. If you do not own the property, you must submit documentation showing a legal, equitable, or leasehold interest in the property.

Attach a copy of one Photo ID from List A. If the address on the Photo ID doesn't reflect the property address, provide document one from List C.

Photo IDs that verify identity and occupancy in the tax year.

- STEP 4 | Discharge Document Required
